Risk is worked out using numbers 1 - 5. The likelihood is given a number and this is multiplied by the number given to the severity of the risk.

The result = the risk factor. This children's soft play risk assessment covers basic practice; it also has the most common risks, preventions and outcomes. If a more detailed risk assessments is needed then it should be done in accordance with your event or company regulations and policy's. 25 is the worst possible outcome, any item reaching 25 would give serious cause for concern and we would not be able to erect the unit. Again it is recommended that clients undertake their own risk assessment to suit their requirements. This risk assessment doesn't not cover movement of soft play and isn't site specific.
